#### FIFPRO DIVISION AFRICA WORKSHOP IN GHANA

The FIFPRO Africa Workshop on Communication and Administration, held in Accra from October 20–24, 2025, brought together football union representatives from across the continent to strengthen their digital communication and administrative capabilities. The session began with an interaction led by a clinical psychologist, Sharon Anang Aseweh, who engaged the players in an hour-long group discussion focusing on trauma recovery, coping mechanisms, and mental resilience. The psychologist emphasized the importance of acknowledging emotional pain while drawing strength from unity, teamwork, and shared experiences.

PFAG Secures Justice for Francis Adjetey in Landmark

The Professional Footballers Association of Ghana (PFAG) has successfully supported player Francis Adjetey in his long-standing dispute with Accra Hearts of Oak S.C. over unpaid entitlements. After the Ghana Football Association (GFA) initially declined jurisdiction, the PFA-G pursued the case on Adjetey's behalf to the Court of Arbitration for Sport (CAS)

In February 2025, CAS ruled in favour of the player, ordering Hearts of Oak and

the GFA to pay over GHS 106,000 plus interest and legal costs.

Following the ruling and FIFA's intervention, Hearts of Oak settled the amount in July 2025, leading to the lifting of a transfer ban placed on the

This case marks a significant victory for player rights and reinforces PFAG's commitment to protecting and advocating for the welfare of all professional footballers in Ghana.

Let us continue to play with passion, but always with professionalism and respect for the laws of the game.
